Treasurer's Report:

Balance sheet handed out. Balance is \$32,033.16.

Year end financial statement was changed with spelling corrections. This is a draft. Treasurer will send out the proposed 2010 budget.

Request for a charitable gaming license was brought forth again by a team.

MIHA would have to modify its bylaws to obtain a license.

It was voted down before because the board felt this was not in line with MIHA goals.

The association has to hold the license. Each team would have to possess a 501c3 and separate bylaws to obtain the license.

MIHA does not have the required dissolution provision in the bylaws referring the assets of the organization back to the local government or non profit organization.

Currently we state the assets refer to a charity.

Larry – Questions the exact wording of the dissolution clause in the rulebook.

District 7 – We would have to change the reading to 501c3 in the rulebook.

Rules Chair – Questions that only 4 “gambling” nights can be done a year.

District 7 – There would be districts chosen to have the use that year or combine for the event and split the proceeds

Treasurer – Even if MIHA has a license, the team(s) in question will also have to fill out a form.

2<sup>nd</sup> Vice - Would selling 50/50 be something we'd would like to do at the state meet to earn extra money? There are a lot of people there as spectators.

District 17 – No one under the age of 18 could sell the tickets.

Chair – Does not want any gambling at the shows.

District 14 – The gaming is only limited to four times per year. Raffles and 50/50 are unlimited.

District 7 – If the license was obtained it would sit and be available for raffles.  
District 19 – By getting this license we open up to the next step until we are gambling.  
Secretary – Raffles and 50/50's are looked at differently than gaming.  
District 7 – Under Roberts Rule of Order shouldn't this decision to get the license be covered under the governing body rule change?  
District 14 – Regarding the dissolution of funds state law always supercedes our bylaws.  
Larry – The statement of dissolution was just put in a few years ago. The lawyers didn't make any reference to it when we created it.  
\*\*Chair – Will research the compliance and bring it back to the March meeting.  
This year's audit will consist of districts 5, 8, 9, and 14. District 14 is all set.  
District 9 – Are all teams to be done?  
Treasurer – All teams were done last time.  
Treasurer – Needs the information by the annual meeting.  
Treasurer – The SOP on the web for financial statements should be pulled.  
According to the rulebook all financial statements are due by 16<sup>th</sup> of January.

Old Business:

A. Registration Fees

Fred Stockley handed out revised copies of the proposed registration fee chart.

Fred – Changed the numbers around. Reviewed the doc with the BOD.

District 9 – Appreciates how much time was spent in creating the chart. Does feel it is unrealistic to ask for an increase fees. Would like to see it \$5 or \$10 more. Favors proposal 2 over 1.

Fred – Started this to invoke talking of change.

Rules Chair – Why don't we get X dollars back per rider instead of a flat fee?

Fred – The chart reflects that option. The negative impact on districts was greater.

District 18 – Feels we need the change and likes proposal 2.

District 14 – A \$5 increase would cover the per rider hit plus have extra.

2<sup>nd</sup> Vice Chair – In district 4 fees were raised to cover the extra costs necessary. Will some districts reduce their fees to incorporate the increase?

District 19 – There will always be some districts not as fair. The state would have to pay for everything.

2<sup>nd</sup> Vice Chair – If we had the state pay for everything we'd be less likely to save money.

District 7 – Last year was the first year their district collected more. With proposal 1 she wouldn't charge anymore than what is being charged already.

District 14 – Their district charged \$5 extra to buy new timers. It is realized they are in a unique situation and other districts may not be able to charge the extra.

- District 9 – Thinks maybe we should look at the per rider avenue and have a minimum of \$1500 still going to the districts.  
Fred – It would negatively impact the state.  
Chair – Would like to have the per rider fee but have \$1500 be the minimum.

C. Trophies

2<sup>nd</sup> Vice Chair – Crowne Trophy is not local to Michigan. They stated their price was going up \$5 to \$7 per trophy. They said the vendor was going up.

Action Awards stated that for right now they will be the same price.

Crowne has not yet sent a quote.

Action is sending a base to review. It may save us \$1 to \$2 per trophy.

New Business:

A. Team Building Strategies

Rules Chair – We don't assign things to committees. We need to make a better effort to assign jobs in committees. Too much is being put on one person.

District 17 – The committee head doesn't contact the other members.

Rules Chair – We need more diligence, more communication. Email is a good way to accomplish this.

B. Rulebook Changes

Rules Chair put all the changes in the proposed rulebook. All are highlighted. Most are wording and clarifications.

District 9 – Sees the work done and sees a lot of negativity because they can't see what the rule was and what the change is separately.

Chair – Sees the same.

Rules Chair – How is she to show this?

District 14 – This needs to be on a ballot anyway.

Rules Chair – Underlining refers to junior

District 5 – In their 4H council bylaw changes they use strike through to indicate what is old. Then add the new. They indicate if items have moved.

Rules Chair – Is concerned about the paper being used.

District 9 – If it goes to the DC's they are responsible for distributing.

District 17 – Will send out the information in both formats.

District 18 and Larry – Both state if the intent is not to change anything there is no discussion.

Rules Chair – How many rule changes were sent?

The suggested changes included the standard size of a dressage arena. Four saddleseat patterns were created and designed for a true saddleseat horse.

Also included the size of the box for the two man relay, but guessed at it.

District 5 – Had water issues and had to move the box. Also questioning saddleseat patterns, a true saddleseat pattern does not include halts or turns.

Can they be changed to reflect less of those?

District 14 – When a simple lead change is called for will a flying lead change be counted down?

Rules Chair – Yes

Rules Chair – Received a change for gymkhana at states so everyone runs twice as they do at regionals. They would also like flags moved to an alternate and poles made a permanent.

District 14 – 4H does flags and almost all gymkhana groups do.

Rules Chair – Williamston put in a change for unapproved obstacles in trail. They also would like the pattern to be enough to place the class instead of having the pattern and railwork.

Rules Chair – Put in for a change to the teams going to regionals. She would like the reserve team to have the option to go also.

There will be a time change to the rules meeting. Doors will open at 9:00 am, registration by 9:30 and meeting starting at 10:00.
