A. 2017 Rule Change Review

Rules Chair: We have a few less changes submitted this year.

- 2. 2nd VC: They voted last year to pull a pattern due to weather conditions. This rule change limits flexibility.

D2: Their district was very disappointed at regionals when not all the patterns were run on the first day. Chair: Keep in mind when you're discussing this with your coaches you can opt to try and ask for a friendly amendment.

D14: If you do a vote to accommodate due to your facilities at the district level, should it flow the same into regionals. Just because it is in the book doesn't mean your region can't hold a vote to alter to meet their conditions.

D5: Track the vote in your district or region which alters the format.

- 3. The rule change is not correctly done. It is not being reviewed. It will not be included in the packet.
- 4. This cannot go through because of invalid article number. It will not be in the packet.
- 5. Looking to add letter O.
- 6. Asking for helmets in bareback.
- 7. Not written in the proper format. It will not be in the packet.
- 8. 2nd VC: This makes the strides concrete in the patterns.

D2: In her district if a rider is unable to walk the course they can walk it with their coach. They had issues in regionals making it to walk the trail pattern.

D4: They had to move trail very far away from the south arena to the infield hoop house.

D13: Are we writing a rule change for a circumstance?

Chair: It is written correctly and will be in the packet.

2nd VC: This stems from the instance at the state meet.

D13: Does this mean if they fall regardless of coming in or going out they are DQ'd.

20. Adding Dressage to the class list.

2nd VC: This needs to be planned as there is considerable time involved in adding the class times and finding the correct judges for it.

D5: The biggest objection was that dressage is based on the horse. She knows that can be adjusted, but this was the biggest issue the last time it was suggested.

D10: If it's added does that give hunt seat and saddle seat more classes than western?

2nd VC: It would alternate each year. Also, there is no apparel guidelines.

D12: What about a dressage ring?

D10: When this was first brought up, he thought about it and thought if you could alternate jumping and dressage. This would help make sure all your seats have the same number of classes.

D2: Has there ever been a time a district has run to find what kind of time and requirements are needed? Is that something a district could do?

2nd VC: That could be done but not used as part of the show in the number of slots and points to determine who moves on.

D4: You would have dressage kids joining a team where their points wouldn't even count. They would be paying fees and not actually contributing to the team.

21. Adding 5th graders to the junior division.

D6: Asks if the 5th grade would have to be in the same middle school.

D13: It would fall under the same rule we have now as to what school they will attend the next year.

22. Potential rule addition suggestion for the board. Page 10 on H about coaches being responsible for financials. It does not state there is a penalty for not turning one in. For the district, it does have a line for the DC and treasurer. If we took that line and added it to H, it would allow us to impose sanctions against the coach.

D14: Any rule infraction in the rulebook states it can have sanctions imposed. She isn't against it, but it would be redundant.

D12: It states on the website that if they are not in by the winter meeting they cannot vote. What do you do with a coach that is not moving into the next year?

D5: If it isn't in the rulebook then it's an empty threat. If the statement is under the team there is something to stand on.

Our forms could be changed to combine those things we need in our organization.
