A. Dressage

Proposal covered by Joann Kosanic
This will add 2 classes
Team slots numbers will not change
Vote would be a 2-year pilot program
2 Dressage test patterns
Hunt seat saddle and conservative clothing will be allowed

New Business:
A. D2 Definition of "Educational Institution

D2: Has a school district which wants to become more involved. Our definition of an educational institution requires them to set up 3 separate teams for 3 separate schools.
Their district has separate sports teams per school for all other sports. This will be considered a team. They allow the students to join clubs affiliated with the different schools.
D9: If this were to go through you'd be looking at mass teams like Ann Arbor, Zeeland and Lake/Milford.
$2^{\text {nd }} \mathrm{VC}$ : If we allowed one school, we would have to allow it for all.
D9: They could form super teams.
$2^{\text {nd }} \mathrm{VC}$ : Suggested having one person be the head coach for one of the teams, and be the coordinator for all the teams. This person would appoint the coaches for the other teams.
D2: Can an entire district be an educational institution?
Chair: No they cannot.
B. D13 Registering 501c3 with gaming commission

Chair: We discussed this before, and remembers it being a lot of paperwork and potentially some insurance consideration.
D13: There is a way to get MIHA registered as a 501c3 with the gaming commission. She is willing to investigate it. She is concerned with MIHA in the event any district is performing drawings or raffles. The difference is whether the fundraising is a game of skill or a game of chance, if it is conducted the same day and the prize is less than \$100.
C. Code of Conduct
$2^{\text {nd }} \mathrm{VC}$ : The board has come up with a coach's code of conduct. This comes from 4 h and MHSAA. The idea is to put this in the coach's packet each year. She would like to see it evolve to include parents and riders. Proposed CoC is read.
D9: Thinks it's a good idea. Many who are a varsity sport already have to sign a CoC and take classes. Anyone members of USEF, the new requirments came out this year must go through a CoC training that highlights training, coaching and anti-bullying. USEF members get it free otherwise it is $\$ 20$.
$2^{\text {nd }} \mathrm{VC}$ : The coach's form will be amended to require the form each year.
$1^{\text {st }} \mathrm{VC}$ : Doesn't believe we need a rule change to add a CoC to the registration, but will need to have a reference to it in the constitution. $2^{\text {nd }} \mathrm{VC}$ will come up with the wording for the rule book.
D. Adding a Coach

Chair: Sent out a questionnaire. We do have a policy on when a coach resigns. The outgoing coach can recommend a coach, but the DC ultimately has selection and approval.
$1^{\text {st }} \mathrm{VC}$ : If you have a head coach resigns and the athletic director doesn't have jurisdiction, there is no place where the outgoing coach appoints the incoming coach.
