Treasurer's Report

Report was not provided but will be once the treasurer is able to get into her computer. Total balance in all accounts is \$122,397.00. Bills paid since January were Spartan Printing, several scholarship payments, and trophy house amongst several other expenditures. Treasurer is continuing to have issues with her state issued computer. She was hoping it would last but it is looking more and more like she has to replace the QuickBooks software. D9 believes that she should also replace the computer. She would like speak to the finance committee and make a decision on how to proceed. Bob Clogg, 1st Vice Chair would like to be added to that meeting to assist in the discussions.

- E. Background Checks The Executive Board discussed moving away from the standard CSC checks and using a program along the lines of I-Chat for criminal background checks. There will be more to come and will be discussing this more in future meetings.

B. Accident Insurance

The 1st Vice Chair is still missing meet dates for the following Districts 1, 4, 13, 18, 16, Region B and Region E. For Region E and District 4 they are waiting on the Fairground contracts to be listed.

The medical coverage given to all riders is costing the organization \$8.00. It is now to a point whether it is worth having based on the cost. Fees are not changing for this year but will need to be looked at in the future years. There was a question as to whether this coverage could be optional. This will be run past our insurance carrier and may cause an additional burden on the DC to keep track of who does and who does not have coverage.

C. MIHA Storage Options

Our storage unit is too much for what we need to store. We are looking at getting rid of our storage unit and replacing the current organization trailer for about \$6,000.00. We would then store all items in the new organization trailer. If anyone knows of a trailer company that would be able to help with that contact the State Chair.

The 1st Vice Chair is looking to clean and organize the current storage unit the first weekend in May and can give a better inventory of what is in there.

This item will be tabled and revisited at the next meeting after the storage unit is cleaned.

D. Rulebook Options

Due to the lack of updates to the 2021 rulebooks, we are looking to save money by printing addendum to the 2020 rulebooks. There would also be a downloadable 2021 rulebook and insert for the 2020 rulebook from the website. We currently have 1 box of 2020 rulebooks and an additional box would cost around \$150.00. This seems to be the normal for most organizations that only have minor changes. There are about 135 rulebooks in a box. There was discussion as to whether moving forward it is necessary to even print the rulebooks.

Motion: MIHA will print addendum leaflets to supplement the 2020 rulebooks for the 2021 season. If additional 2020 rulebooks are needed, then 1 additional box will be ordered.

E. Background Checks

MIHA would like to up their background checks from the standard sex offender registry to a more comprehensive check. Currently checks from the school or 4H takes a long time and you may or may not receive a copy of that check. There were two options discussed. First was NICS which is a national background check that provides a website with a contract for us to use. There could be a link placed on the website for individuals to use. The cost would not be on the organization to pay. The cost would be on the person requesting the check. The second source would be the use of IChat. This is a free service to non-profits that will give you background checks at a State and local level.

Being the second largest horse organization in Michigan we need a more thorough check for individuals working with our riders. If we decide to move forward with this this organization needs to decide what our organization would consider acceptable or not acceptable for acceptance as a coach. There was a suggestion that a committee be formed to vet out background checks that come back as having issues in order to make sure they are valid issues. The membership committee will look at creating some guidelines for these checks.

New Business:

A. Covid-Task Force

We will need to set some recommendations for our junior meets. These recommendations would be published to the District Chairs for distribution to their teams. There are questions from the Districts as to whether our riders will be required to be tested on a weekly basis like the other sports. This is a voluntary process based on school. If the school requires it to be done, then the students should be tested by the school. We do not have the facilities or tools to do this in our organization.

B. Community Teams

There is not a need for community teams within junior teams because they can co-op. At the HS level there were some issues and will not be continued for this year. The SOP was for 1 year and it is not believed to be an issue with any schools not continuing sports.

Committee Reports:

State Show – All judges are hired. The schools load in on October 13th and the meet is October 14-17, 2021.

Rules – No further report or discussion

Regional – (A) Trying to get all their people together to put together another indoor arena. All judges are hired. (B) Contracts are signed with Shiawassee. All but 1 judge is hired. (C) All judges are hired, and fairgrounds are reserved. (D) All set and nothing major to report. (E) Has lost the battle and will likely be holding the meet outdoors. No contracts for Ingham county have been released yet.

A. Accident Insurance- Marc- talked to Mr. Block and it looks like the policy expired on March 1 for rider insurance (helping with deductible). Hope to have it in effect for those who have horse shows this weekend. Hoping to have a quote by Friday.

D19: They should prorate right?

Marc: they should have it put into effect by May

Doyle: what happens if they don't

Marc: We will have to cover it, it is \$2,500. Hopefully everything goes okay but if not we will need to step in and secure coverage. It just got lost in the transfer.

Steve: when did she let it go

Bob: Unsure; we were covered from 3/1/2020-3/1/2021.

Marc: We will just have to get it. We need to discuss if we will keep it, we discussed not keeping it at the last meeting.

D19: had her coaches meeting and asked what the data looked like (how often is it used).

Bob: I've been DC for 5 years and I can remember 2 instances

D19: Lots of people in her district already have a high deductible Candice: I've had several over the years during regionals. All came back and thanked us for having it as it did help cover an ambulance ride that would not have been covered.

Michelle: we don't even bring it up unless someone gets hurt. Coaches poled parents and determined it would not be a determining factor if it was gone.

Steve: Used it a couple times and those that use it are thankful to have it.

Marc: Well I think we table it and discuss it.

B. MIHA Storage Options

a. Marc: we are going to vacate the storage unit as he thinks that they can repackage the trophies and fit everything in the trailer. We do have to buy tires for the trailer because I blew one out coming today. Guy who helped him fix blown tire might have tires for us

C. Background Checks

- a. Marc: Ann Lawter is very insistent that we push the background checks back on the school (for the coaches who volunteer for the school to coach) as if someone does something "dumb" they will more than likely go after the school and not the organization.
- b. Marie: We have some that are just not approved by the school at all.
- c. Bob: I think this would cause more trouble than not. I realize the liability is there but realistically if the school isn't involved we at least did our due diligence.
- d. Michelle: this is what is currently happening: if school runs a background check on a coach, they are background and CSC checked every 12 months. Those reports are reviewed by a limited number of users and then are shredded as long as they are cleared. Arrests, court records, convictions, warrants, incarceration records etc. a standard background check would only carry credit, professional history and sometimes sex

- offenses. Currently, the schools and 4-h use I-CHAT. If you want to have them release a check for you it must have been done in the last 12 months for the purpose of care and custody of children.. should not say other as that could be CCW or clearing for Notary. I-CHAT is \$10/pp. If they already have it through 4'h or school we could get it for free.
- e. D2: I do the I-CHAT for the school and it gives us codes, not direct. Someone has to monitor it throughout the year so that if you are arrested throughout the week, someone is notified.
- f. Marc: The DC's know your coaches, the Exec board does not.
- g. Marie: we shouldn't need to do it with teachers and 4'h leaders. Could they give it to us?
- h. Doyle: I have 90-95% of my coaches that fall in the same category that Marie is talking about. Those few that don't, we can look at doing something with but I know if the school has approved every one of them. Since the school acknowledges them then the background check should have been performed.
- i. Steve- you have to be careful as if you pick some or not others
- j. Michele: as an organization we have to decide what makes them unsafe to work with kids.
- k. Lisa C.: What about those that have not been prosecuted
- 1. Marc: I think we have to do something, it's in our bylaws that we have to do something.
- m. Bob: I check all of our CSC's
- n. Marc: Let's do this, if you tell us as an EB that you would like us to do the I-CHAT, we will pay it and do the I-CHAT for you. Or, we can set up an expense for it.
- o. Bob: so you're saying the I-CHAT or the CSC? We will need to set up a committee to determination
- p. D2: ICHAT can make that determination for you, the only downside to I-CHAT is that you need to go through the State Police training which is 4 days and then update it week after week.
- q. Candice: I think right now the bylaws only say CSC, this is something we will need to work on in November/December if we want to change. The Exec Com. Should work on this and present this in Nov/ Dec.
- r. Bob: put it in all locations.
- s. Marc: we should table it until November.

D. Covid Task force

- a. Lauren: task force met and have come up with recommendations.
